WITH THE INCREASE IN HATE CRIMES AFFECTING COMMUNITIES ACROSS THE COUNTRY, THE STOP HATE PROJECT HAS EMERGED AS A CRITICAL VOICE IN THE FIGHT TO END HATE. WITH A COMMUNITY-CENTERED APPROACH, THE SHP PROVIDES RESOURCES TO SUPPORT LOCAL ORGANIZATIONS AND LEADERS COMBATING HATE ACROSS THE COUNTRY. IN 2017, THE SHP LAUNCHED A PARTNERSHIP WITH THE INTERNATIONAL ASSOCIATION OF CHIEFS OF POLICE (IACP) TO INCREASE THE DIALOGUE BETWEEN LAW ENFORCEMENT AND COMMUNITIES MOST AFFECTED BY HATE CRIMES. THE LAWYERS' COMMITTEE IS AT THE FOREFRONT OF EFFORTS TO ENSURE EVERY AMERICAN IS PROVIDED EQUAL ACCESS TO THE BALLOT BOX AND IN FIGHTING AGAINST THE ADMINISTRATION'S ATTACK ON VOTING RIGHTS. THE VOTING RIGHTS PROJECT (VRP) LED THE CHARGE IN LITIGATING AGAINST THE PRESIDENTIAL ADVISORY COMMISSION ON ELECTION INTEGRITY, WHICH WAS LAUNCHED TO SUPPORT UNFOUNDED CLAIMS OF VOTER FRAUD IN THE 2016 PRESIDENTIAL ELECTION. THE VRP SUCCESSFULLY LITIGATED TO EXTEND THE REGISTRATION DEADLINE FOR GEORGIA VOTERS IN THE STATE'S SPECIAL CONGRESSIONAL RUNOFF IN JUNE. IN ADDITION, THE VRP CHALLENGED THE DISCRIMINATORY METHOD OF ELECTING JUDGES IN STATES WHERE IMPORTANT DECISIONS AFFECT MINORITY COMMUNITIES, INCLUDING IN TEXAS AND ALABAMA.
